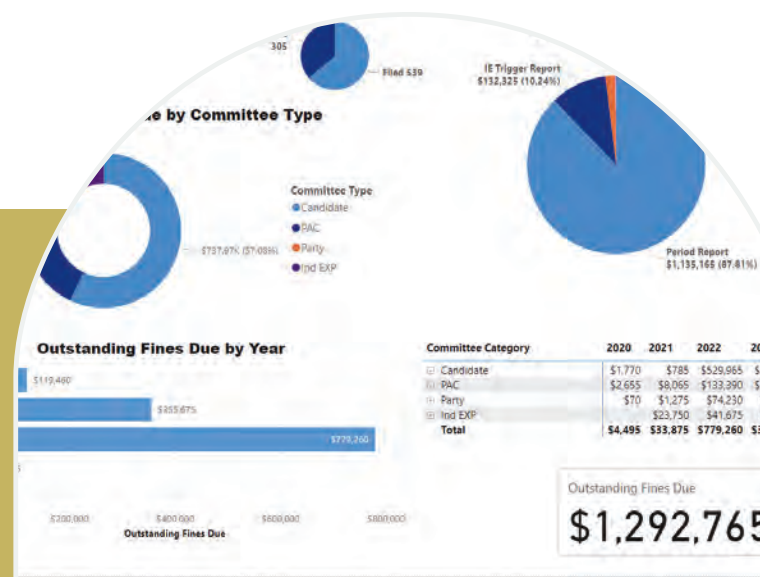

### CHALLENGE

The Arizona Clean Elections Commission and Secretary of State's Office faced the challenge of managing a vast volume of complex data related to campaign finance filings.
